Daycare:

<animal> is participating in daycare. This agreement covers daycare services provided for the 20__ calendar year.

Playtime Participation:

By dropping my pet off for daycare, I understand that he/she will be participating in group play outside in the provided play yards. During play time your pet will be playing with other dogs. While we take all precautions to group dogs with similar play levels and sizes, dogs can be unpredictable. Incidents such as bumps, bruises, scratches, and bites can occur during playtime. The team at College Park Road Boarding Kennels monitors the play yards and the dogs' behavior to reduce the risk of these incidents. By signing this agreement, you acknowledge that you will hold College Park Road Veterinary Clinic and Boarding Kennels harmless if such incidents occur during your pets' stay.

Happy Hound Policy:

It is our goal to ensure every dog participating in our daycare program is happy and healthy while playing with their friends and interacting with our kennel team. If it is observed that your dog is showing signs of stress or anxiety, difficulty finding friends to safely socialize with in the play yard, fearful when walked through our facility or when taken in and out of their kennel by the team, our daycare program may not be the best fit for your dog. If any of these concerns are observed, our team will immediately notify you and help determine if your dog should continue with our daycare program. Daycare is meant to be fun and a healthy outlet for dogs! We never want to see our daycare dogs stressed, nervous or fearful while participating in our program.

General Policy for Boarding and Daycare Services

Food, Bedding and Medicine/Supplement Policy:

Only prebagged meals are accepted for boarding pets. We will not accept bulk food. Hard treats are prohibited. If your pet runs out of food or you do not provide food, we will provide food at an additional cost - \$4 per day for dry food and/or \$5 per day for canned food depending on your pet's needs. Our in-house food is Purina ProPlan.

Bedding will be provided for pets during their stay. We will provide plush blankets or a cot to your pet. We kindly ask that you leave all personal bedding at home.

College Park Road Boarding Kennel – Boarding & Daycare Agreement

All medications or supplements must be brought in the original container. All veterinarian prescribed medications must be clearly labeled with the dosage and administration directions. Only oral medications will be given at the boarding kennel. If your pet requires injectable medications, such as insulin, your pet will be required to medical board at *College Park Road Veterinary Clinic*. Pets requiring injectable medications during daycare hours will not be allowed to participate in our daycare program.

Emergency Situations | Emergency Contact:

College Park Road Boarding Kennels will make several attempts to contact you in the event of an emergency regarding your pet while in our care. If you are unable to be reached, the provided emergency contact listed at the end of this agreement will be contacted. If neither you or your emergency contact can be reached and emergency treatment or surgery for your pet is deemed necessary by a veterinarian with College Park Road Veterinary Clinic, said treatment or surgery will be initiated. You will incur all financial responsibilities. This includes parasite treatment, lethargy, vomiting, and diarrhea. All incurred costs must be paid upon pickup of your pet.

The emergency contact listed on this form must be available to pick your pet(s) up if the need arises and/or give authorization for treatment. If you do not have an emergency contact available, the Kennel Manager and/or Hospital Manager will determine if your pet can participate in daycare or boarding.

Abandonment:

If your pet is not picked up within 24 hours after the specified pickup date/time and/or boarding is not notified of your need to extend your pet's stay within a 10-day period, your pet will be considered abandoned. After 10 days your pet will become the property of College Park Road Veterinary Clinic and Boarding Kennels. This does not release you for payment of services rendered by College Park Road Veterinary Clinic and Boarding Kennels.

Social Media/Advertising:

I understand that pictures may be taken of my pet during their stay. These pictures may be used for advertising or social media posts by College Park Road Veterinary Clinic and Boarding Kennels.

I hereby assume full responsibilities for any harm caused by my pet(s) while in or on the premises and while my pet(s) are under the care of College Park Road Veterinary Clinic and Boarding Kennel. I further agree to indemnify College Park Road Veterinary Clinic and Boarding Kennel, its owner and team for any loss, liability, damage, or costs they may incur due to any harm caused by my pet(s). I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of South Carolina. I agree that should a court determine that any provision waiving liability is deemed unenforceable, College Park Road Veterinary Clinic and Boarding Kennel liability shall be limited to the funds paid to it by me for taking care of my pet(s). I further understand and agree that any injury or illness that develops with my pet(s) will be treated as deemed best by College Park Road Veterinary Clinic and Boarding Kennel, and that I assume financial responsibility for any and all expenses involved, even such expenses later found to be unnecessary. Furthermore, should my pet(s) pass away during my absence, I direct the veterinarian may be called to safe keep my pet(s) until I return.
